



## **Request of Release Form**

### **Conditions of Release**

Within the Metropolitan Senior Football League, a player having played for one of the teams of the LMFS in the previous season or a part of the current season belongs to this team for the following season and cannot transfer to another team from the LMFS, unless the following conditions are met:

#### **A - Procedure of request for release**

- I. The player must make a request personally and officially with the President of the current team. It is understood that a third person cannot make the request in place of the player;
- II. It is the responsibility of the President of the said team to provide a Request of Release form to any player who makes the request and as soon as possible after this request is made;
- III. The player must obtain the permission of the President of the current team to change teams and must sign an original of the Request of Release. In addition to having the President of the current team sign the form, this procedure must be completed with respect to the “release date” which is always on the 15th day of July of the current year;
- IV. When this form is completed and in possession of the player that has been released, it is the responsibility of the player to present it to the President or the delegate of the new team to which he wants to join. Finally this form must be signed by the President or delegate of the new team;
- V. Each team must preserve one copy of the Request of Release form for their respective records.



## **B - Payment in the event of litigation**

- VI. In the event of litigation, each part has the right to address the President of the LMFS directly. The President will establish a committee made up of at least five members of the LMFS Executive Committee not involved in the litigation so that this committee can review the case and make a final decision, in the name of the LMFS;
- VII. A player who has a debt towards his current team, whether financial or in terms of equipment, can not join any other team in the LMFS, for as long as he has not entirely fulfilled his obligations towards his team of origin;
- VIII. In case of a special rule concerning the transfers between teams is instituted following an expansion, the "Procedure of Request of Release" must be observed;
- IX. A player that wishes to change teams but does not manage to obtain a release has the possibility of taking one year without playing. This will make his release automatic. This is provided that article VII is respected;
- X. If the request is made after the "release date" of July 15, it is possible for two teams to agree to a release and transfer. The two Presidents can discuss the situation. No means of pressure will be tolerated so that a President releases a player whose request will have been made after the "release date";
- XI. A player who is cut off from the team, following a selection camp, obtains his release automatically provided that article VII is respected.
